Thank you for your support in 2022! It was a year of program evolution and organizational growth for Marguerite's Place. 81% of our transitional housing residents moved onto permanent housing opportunities, ensuring long-term stability for their children; our classrooms inspired children to grow through trauma-informed, social-emotional learning; and this year we formally launched our Family Empowerment Program, providing supportive group-based programs for parents to learn new skills together and build a network of parent support.

As we begin our 29th year of operation, we look towards growth. The number of families in crisis in our community has grown exponentially, and our mission compels us to ensure that vulnerable families are not left behind. We are assessing our capacity and opportunities for expansion to ensure that more families experiencing homelessness can meet their basic needs, build success skills, and ensure their family's long-term wellness.

At it's core, **the work of Marguerite's Place is for the community, by the community**. Everything we do is made possible by the steadfast support of the many individuals, corporations, and foundations across our region. We are grateful for your continued investment and look forward to empowering even more families in 2023.


